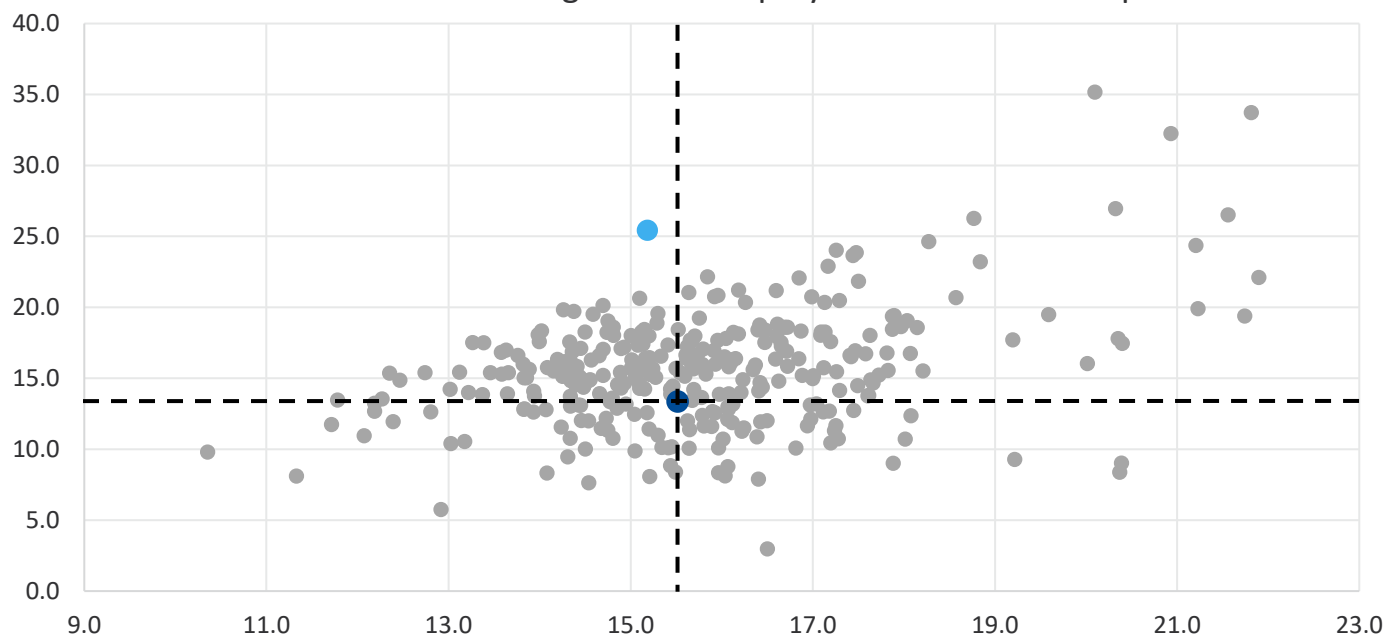
Investment Philosophy
