This milestone reaffirms Fiera Capital's commitment to responsible investment practices.

Signatories of the UK Stewardship Code are required to annually report on their stewardship policies, processes, activities, and outcomes for a 12-month reporting period, setting a high stewardship standard.

With this acceptance, Fiera Capital joins a cohort of 277 signatories. The Company's inclusion signifies its approach to aligning financial objectives with the broader societal interests, thereby strengthening the bridge between financial performance and responsible investing. This status underscores its approach to stewardship and reflects the Company's commitment to embedding sustainability considerations into its investment decisions.
